- **In 2005** We decide to build up our own Factory in Bangkok Duty Free Zone, with an area of, 7250 Sq.Meters.

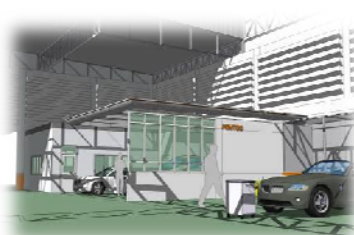
